

## 1-YEAR LIMITED WARRANTY

- A.** G-Lites® hereby warrants to the original purchaser that G-Lites® professional products are free of manufacturing defects in material and workmanship for a period of 1 Year (365 days) on all internal parts from the date of purchase. This warranty shall be valid only if the product is purchased within the United States of America, including possessions and territories. It is the owner's responsibility to establish the date and place of purchase by acceptable evidence, at the time service is sought.
- B.** For warranty service, send the product only to our G-Lites® factory: 42245 Remington Ave, Ste. B17, Temecula, CA 92590. All shipping charges must be pre-paid. If requested repair or service (including parts replacement) is within the terms of this warranty, G-Lites® will pay return shipping charges only to a designated point within the United States except Hawaii or Alaska. If the entire instrument is sent, it must be shipped in its original package. The accessories should be shipped with the product. Customer must be very careful when including accessories, placing them in a separate bag within the original box/case in which case is shipped. It is necessary that customer submits complete list of accessories shipped, indicating type and number of pieces per type. That list will be checked upon arrival to G-Lites® location.
- C.** This warranty is void if the serial number has been altered or removed; if the product is modified in any manner which G-Lites® concludes, after inspection, affects the reliability of the product; if the product has been repaired or serviced by anyone other than the G-Lites® factory unless prior written authorization was issued to purchaser by G-Lites®; if the product is damaged because not properly maintained as set forth in the instruction manual.
- D.** If warranty is declared void, customer must assume all costs related to shipment back to the original place from where it was received, or any other place where the customer wants to receive it.
- E.** This is not a service contract, and this warranty does not include maintenance, cleaning or periodic check-up. During the period specified above, G-Lites® will replace defective parts at its expense, and will absorb all expenses for warranty service and repair labor by reason of defects in material or workmanship. The sole responsibility of G-Lites® under this warranty shall be limited to the repair of the product, or replacement thereof, including parts, at the sole discretion of G-Lites®.
- F.** G-Lites® reserves the right to make changes in design and/or improvements upon its products without any obligation to include these changes in any products theretofore manufactured.
- G.** No warranty, whether expressed or implied, is given or made with respect to any accessory supplied with products described above. Except to the extent prohibited by applicable law, all implied warranties made by G-Lites® in connection with this product, including warranties of merchantability or fitness, are limited in duration to the warranty period set forth above. And no warranties, whether expressed or implied, including warranties of merchantability or fitness, shall apply to this product after said period has expired. The consumer's and or Dealer's sole remedy shall be such repair or replacement as is expressly provided above; and under no circumstances shall G-Lites® be liable for any loss or damage, direct or consequential, arising out of the use of, or inability to use, this product.
- H.** This warranty is the only written warranty applicable to G-Lites® Products and supersedes all prior warranties and written descriptions of warranty terms and conditions heretofore published.
